4. Lottery sub-committee meeting 30.11.21:

Lottery Draw

- KJ It was discussed at the lottery sub-committee meeting 30.11.21 that we need to look at ways to introduce more people to observe the draw (adjudicators). It was agreed that AJ & KW will take over the administration of the draw effective 2.12.21. It was proposed the draws would take place each Thursday at the Civic building in Port Talbot with the relevant adjudicators and posted on the member Facebook page each Friday.
- All present were in agreement.

5. Finc & Gov sub-committee meeting:

DJH said:

- We've previously agreed to contribute 20% from the lottery proceeds into the
 wellbeing pot, but to date, we're struggling to find wellbeing activities. Major spend to
 date has gone on Luminate and PERKZ. We started the financial year with £3,000 in
 the wellbeing pot. We've agreed to put £22,000 in, which gives £25,000 and we've
 only spent £5,000 to date.
- The proposal to the group is to reduce the 20% to enable more spend on Lucky Fridays lottery prizes. All present were in agreement.

7. NPT Health and Wellbeing Group - Financial Statements

Lucky Fridays Account

DHJ - we started off the year with £17,000 in the bank. To date we have £73,000. We've paid out £56,000. We've transferred £22,000 to the wellbeing account. That leaves us £12,000 in terms of the lottery.

Wellbeing Account

DHJ said - the Council will reimburse NPTHWG for the Virgin Go challenge. We've paid out £5,000 to PERKZ and also paid for Luminate.

8. NPT Health and Wellbeing Group - Risk Register

• KJ explained that there are some £1 members who remain on standing order for the lottery following their retirement/departure from the Council. It was agreed that a

letter would be sent asking them to stop the standing order.

9. NPT Health and Wellbeing Group - Well-being Activities:

Bonus Prize Poll

• KW gave a summary to the group that following the online poll on Facebook and Yammer (19.10.21) a combined 620 votes from members informed the Festive Fridays Christmas bonus prizes.

Mal's Marauders

 SO & DJ mentioned improving men's wellbeing through walking & talking with Mal's Marauders at an approximate fee of £250 per day. DJ confirmed Mal's Marauders was part of a 3 day programme used in Tata Steel called 'the number 52 bus'.

Action

SO/DJ to provide details of what the £250 fee would include.

- SO & DJ added that Mal suggested he'd like to roll it out to females as well, because what we've done is predominantly male.
- SR commented that in her experience, different people respond to different things.
 But queried if the trained 12 employee champions in mental health across the Council could be of use in some capacity.

Ideas for future activities

A discussion took place on various ideas of how best to use the £20,000+ in the
wellbeing account for the benefit of members. The group discussed several ways in
which this money could be used including wellness packages, £5 cinema and
theatre tickets and others.

Actions

KW to create a poll asking members how they would like to use the remainder of this fund

KJ to contact MIND to see what packages they offer for mental wellbeing.


